Update from your PFT — March 17, 2020:

Negotiations:

As you know from yesterday's communication, PFT Staff was well prepared and anxious to move along with **negotiations** for all four of our units—in fact we had a bargaining session set for 9:00 AM this morning with the PPS negotiations team. However, last evening Governor Wolf ordered the involved state mediators not to attend any bargaining sessions for the next two weeks. Therefore, our session was canceled by our state mediator and we will be unable to hold negotiations sessions for the next two weeks.

We have a session set for April 1—let's hope that we can keep that one.

We will contact PMOIU2 leadership to see it they are ready to set a date to meet in April.

The Continued Debate With the District to Get Members Paid:

Today in a videoconference with District leadership, we did receive verification that our **PCAs** and our **Full-Time Salaried Substitutes** would be paid during this time off.

Though this is obviously great news, we still have been unable to get the District to agree to pay **Day-to-Day Substitute Teachers**, even those working towards full-time substitute status. The District was close to, but did not slam the door on discussion on all categories of Day-to-Day Substitute Teachers.

We are not finished trying to convince them to include everyone in this safety net, and we have

reached out to AFTPA for additional data and support.

** Day-to-Day Substitute Teachers can apply for Unemployment Compensation immediately in case the District does not relent—the seven day waiting period has been waived. **
