## PA COVID Vaccination Update.

Up to 1 million more Pennsylvanians are newly eligible for a COVID-19 vaccine now that the state has moved into Phase 1B of its vaccine rollout, according to *Spotlight PA*. They include [\*\*postal workers, prison staff, incarcerated people, public transit workers, and more.\*\*](#)

Eligibility opened to Phase 1C this past Monday, and everyone age 16 and up should be eligible next Monday—April 19th.
