### **The Importance of Booster Shots & What's Being Lost In Translation.**

From a caseload perspective, the Omicron surge is reaching a plateau or diminishing in multiple states across the nation (*and equally important, in most geographical regions*), and while this is a cause for cautious optimism, it's important to remember that we're not out of the pandemic woods.

Not when America is still averaging nearly 2,500 deaths per day due to Covid-related complications; and not with our nation now beyond the nearly unimaginable mark of 900,000 American deaths due to Coronavirus.

If there's an emerging, repeated theme—it is that the challenge that remains does so largely in the cohort of Americans who have yet to be fully vaccinated (*if at all*), or fully boosted.

As you will see in the first article in the [February 7th NY Times newsletter seen here](#), there is an emerging subset of people of all ages and stripes who are ignoring or downplaying the need for booster shots when eligible. And ignoring them despite strong evidence that boosters are helping to spare lives and prevent more severe illnesses

There's no one reason people are ignoring or delaying booster shots—but sadly, those reasons have had a negative affect on both our caseload and our death rate.

### **Mask Mandates: The Beginning of The End?**

A pressing national question seems to be not "if" mask mandates are coming to an end, but rather, "when?"

One thing for certain is that mask mandates will not be uniformly or simultaneously lifted or enforced nationwide. That's why it is important to be aware of transmission rates and case counts in your own particular geographic area. The discussion about lifting mask mandates remains contentious, with many experts citing a lag in vaccination rates among the school-age population as a reason to not prematurely end mandates.

"Currently, 22.6% of Americans ages 5 to 11 and 56.4% of those ages 12 to 17 are fully vaccinated against COVID-19." -- ABC News/CDC
