Positive News On The Covid Front

The number of COVID cases, hospitalizations and fatalities nationwide has not risen proportionately with the emergence of the BA.2 Covid variant as the dominant strain of the coronavirus in America. That's good news overall—the most recent surge may not be as disruptive or as dangerous as either the Delta or Omicron variants were.

Allegheny County Changing COVID Measurement Metrics

If you read the article above, you learned that the addition of readily available at-home testing has negatively affected accurate COVID case reporting and statistics across the country. Allegheny County is no exception—people who test and test positive at home are often not reporting the results to the Health Department (ACHD).

As a result , the ACHD is now including wastewater monitoring as an accurate measurement and indicator of COVID activity.

" ... Going forward, ACHD plans to release weekly reports of COVID data every Thursday, which will include familiar pandemic measurements, such as numbers of

hospitalizations, deaths, and new cases, as well as less-familiar metrics pertaining to the concentrations of COVID-19 found in the county's wastewater."

" ... [We] have been **guilty on occasion of thinking** of policymakers as **backpedaling when guidance changes back and forth** or **being inconsistent** when **one state makes a certain decision while another does something else**. But I've come to appreciate that that isn't the correct framing.

As variants emerge, targeted policies to counteract the new reality follow in quick order. Reinstating mask requirements after they have been dropped or recommending additional vaccine doses between waves may seem like 180-degree course corrections. **But in reality, these policy changes are the right reactions to the hurricane of COVID-19 that continues on its meandering path across the globe.** -- Dr. Michael Williams
