- **CCS 2.0**

- When will payment forms be available for compensation for paperwork for CCS meetings?
 - *A form was sent on May 3, 2023, to program officers, and will be sent out in the Monday update.*
- Many teachers are reporting that preparing the paperwork from start to finish, especially going through progress notes, has taken more than one hour. Will there be an opportunity for teachers to be paid for more than one hour?
 - *Unfortunately, not, the agreement is for one hour.*
- Where are we as a department with holding CCS meetings?
 - *See Patti's most recent update. Numbers are changing daily.*
- Are there any updates about the delivery of CCS services?
 - *The district and the PFT are meeting on May 12th to develop an MOU regarding service delivery.*
 - *Staff will be paid using ESSER money – which will expire September 2024.*
 - *CCS is not monitored by the state. It is an agreement from a complaint that was filed.*
- Will there be CCS delivery options for this summer?
 - *They are hopeful there will be summer offerings.*
- Can general education teachers deliver CCS hours?
 - *Yes, if they are a certified teacher. For example, an art teacher cannot provide math services, but a math teacher can.*
 - *PSE teachers should, however, be considered first.*
- Request: How is CCS going from a practitioner standpoint?
 - *PFT members shared their experiences with CCS.*
- PFT Update: CCS Servicing

- *Nina reported that the district knows that staff will not complete the service hours for our current workshop rate.*
 - *What would be an acceptable rate for our work?*
- **Revisit: Progress Reports**
 - At our January 2023 meeting, when talking about e-mailing documents to families, a question arose about e-mailing progress monitoring reports. In the minutes it states, “Ms. Camper will consult with legal to find out if progress monitoring reports can be emailed to families.” Are there any updates?
 - *Best practice is to have an agreement with the parent. If an e-mail is their preferred option that should be discussed and documented. If parents want print copies, they are entitled to that method.*
